We are committed to providing our Members with convenient access to your accounts. As part of that commitment, we made an



improving our Online and Mobile Banking systems. While a major change like this can be challenging for everyone, the new systems will give us the ability to continue to add enhancements as new technology becomes available. Our previous systems were no longer being updated or enhanced so it was critical for us to make this change to be able to meet your needs in the future.

The new systems required re-enrollment by all Members. The re-enrollment was required for two reasons. 1. Most of our Members were still using their account numbers as user IDs and we chose to discontinue this practice to improve overall account security and, 2. Also, for your security, we cannot unencrypt your passwords to be able to use them on a completely new system. Everyone would have had to create new passwords at a minimum.

We have received a lot of great feedback from our Members about our new Online and Mobile Banking. Many Members love the new features and the modern look and feel. Some of our Members are struggling through the change which is entirely normal as our systems were the same for so many years. It will take time to get familiar with these new systems and we hope they do make it easier for you to do your banking remotely.

I want to personally thank all of our Members for making this transition with us. We have now re-enrolled over 27,000 Members since our launch in late August.

As the holidays approach, I want to thank all of our Members for your continued loyalty. It's through your support that we continue to thrive and be successful.



New Online Banking - Quick Tips

Did you know that you can now add images and comments to your transaction history within our new Online Banking? Whether you are transferring money to someone, paying a bill or just simply want to attach an image to a transaction, you can now customize your transaction history.

Log on your account, click on History, and select one of the accounts listed in the drop down at the top.

To add a note to your transaction, change the view from "Compact" to "Expanded" then click on the notepad and pencil icon on the right side. Enter your note and click the checkmark to save.




To upload an image, click the little arrow on the left hand side, then click "Attach an image to the transaction."
